- ➤ Thanked Susan Jacobs for the file cabinet. She stated that she still has one more.
- > \$100 donation was received for the tools

New Business:

- ➤ Special meeting was held on Nov. 14th, 2024 and accepted Darlene Sisler's resignation. Held interviews with two candidates to fill Darlene's position. Ronda Rathje was hired. There was discussion as to why Ronda was hired over a veteran. Ronda's resume was in the packet for all to read. Other candidate was encouraged to reach out to other county offices for a position.
- ➤ Can we pay attorney fees for a client? Discussion was held about how we could help a client with fees. Contacting JAG was brought up to help fight military side. Bylaws say that we can help with financial assistance, but do we want to open "that can of worms." Motion was made by Susan Jacobs to research alternative routes and revisit at a later date.
