New Business:

- ➤ Vote on purchase of new computer for Doug: Moved to purchase by Ellis, seconded by Joe Drozd, passed.
- ➢ Bus to Iowa City: If Carroll County Transit accepts the bus responsibilities to Iowa City, should a new schedule be made for Iowa City and Madison? The Carroll County Transit will already take vets to Iowa City if they are on Medicaid.
- ➤ Bus to Freeport: And Rockford. CCTA can take vets to both.
- ➤ Insurance for office: Senior Center pays for liability, VAC can pay for office. Need a fireproof safe?
- Ellis and Wayne to be bonded: For \$2,000? Wayne will follow up. For Wayne and Ellis to be bonded, motioned by Paul Mayer, seconded by Joe Drozd, passed.
- ➤ Raffle to establish a fund to assist veterans currently not covered in our by-laws: It was thought that a raffle for food would be better than a gun. The idea is tabled until the next meeting so Lee can do some research.
